

Open Hearts Place

Equipping families for success!

Do you want to get back on your feet financially? Do you want to be able to buy your own home?

Open Hearts Place will provide intermediate housing for up to 3 years and assist you and your family to overcome current barriers that inhibit your financial, emotional and social stability.

You may apply for the OHP program if you:

- are the parent/guardian of at least one minor child.
- are interested in owning your own home in three years.
- are employed fulltime in a reliable job.
- are able to meet the income requirements.

Application Process is a 4 step process. Applicants will be notified by phone and/or text to proceed to the next step.

- Step 1: complete application. Return July 1 September 1, 2023 with \$25 fee. Address: Open Hearts Place (at St. Matthews UMC, 201 Shady Rest Road, Morganton, NC 28655 or drop off at the church (enter double glass doors) Monday – Thursday 10-5:00 or Friday 10-2:00.
- **Step 2:** submit a copy of your credit report (obtain from Equifax, Experian, freecreditreport.com or etc) and agree to and sign our "Willingness to Partner Agreement".
- Step 3: have an in home visit with your family and two of our volunteers.
- **Step 4**: final interview with Open Hearts Place.

The mission of Open Hearts Place is to provide homes supported by programming in partnership with the community to promote family self-sufficiency.

The vision of Open Hearts Place is to break the cycle of poverty by creating wealth, home ownership, and strengthening families and communities.

Who can apply?

*Applicants must be at least eighteen (18) years of age or older. All persons 18 years or older who will be living in the home must complete an application.

*Applicants must be low or very low income according to US Department of HUD of North Carolina (Hickory-Lenoir-Morganton, MC MSA: Income \$27,000-\$62,550 depending on numbers of family members.

*Applicants must have minor children in the home. If there is a child who will turn 18 years of age while living in an OHP home, that child must also complete an application.

* Applicants must have at least one full-time working adult in the home.

*Applicants must live and/or work in Burke County

Application Requirements

*Application is valid for one (1) year

* A non-refundable application fee of \$25 must be paid before the approval process can begin.

*All required parts of the application must be stapled together and submitted at one time. Expectations of Applicants

*Applicants must provide two (2) written rental references, including most recent landlord, and two (2) written personal references

*Applicants must be willing to work with the Programming Team to become financially independent.

* Applicants must be able and willing to pay (on time) an affordable amount of monthly programming fee (capped at no more than 30% of household income)

* Each applicant's credit report will be reviewed by OHP.

*Applicants must provide a basic background check from the County Clerk of the Court. This will be attached to the initial application form.

*Applicants (18 years or older) will provide a current picture ID attached to the application form. Housing Rules

*Smoking/vaping are not allowed in the home at any time

*No pets are allowed on the property or in the homes

*MAXIMUM OCCUPANCY STANDARDS - 3 bedroom-homes have a maximum occupancy of six (6) persons
